



NEW MEXICO HIGHLANDS UNIVERSITY

Non-Resident Tuition Waiver for Colorado Students

A reciprocity agreement between the States of Colorado and New Mexico allow New Mexico Highlands University to accept certain students from Colorado with a waiver of the non-resident portion of tuition charges. The number of students who may receive waivers is limited, and the number may vary from year to year. For purposes of administering the agreement, the following policies will be followed in selection:

- A. Application- Each student requesting a waiver must complete the proper application (on the reverse side of this form) and return it to the Admissions/Registrar's Office, Box 9000, Las Vegas, NM87701.
- B. Selection- A new student must meet regular requirements for admission to the University and must not have any grade average deficiencies.
 - Freshman** 2.00 cumulative high school grade average
 - Transfer Student** 2.00 overall cumulative grade average on college or university work attempted
 - Graduate Student** 3.00 cumulative grade average on all undergraduate and graduate work application to the major field of study at New Mexico Highlands University (Must apply for regular graduate admission. Students admitted on probationary admission status do not qualify for waiver.)
- C. Renewal- The student must be in good academic and disciplinary standing and must complete the waiver application each semester for renewal. Academic and or /disciplinary probation disqualifies the student.
- D. Priority for Granting of Waivers- Because the number of waivers may be limited to a smaller number of students than will apply, the following priorities will be followed for the granting of waivers.
 - 1. Currently enrolled students who have maintained good standing at NMHU and who submit an application for renewal before the last day of the semester prior to the semester for which the waiver is being requested. Late applications will be included in Group 3.
 - 2. Former students who have been out of school one or more regular semester, who have not attended any other college or university and who apply for renewal before the last day of the semester prior to the semester for which the waiver is being requested. Late applications will be included with Group 3.
 - 3. New students and former students re-entering from another college or university, regardless of classification (freshman, transfer, graduate student) on a first-come, first-served basis, which will be determined by date of receipt of the application. The application for the waiver may accompany the application for admissions to the University, in which case, the earliest eligibility date will be the date of admissions to the University, rather than the date of receipt of the application. No tuition waiver will be granted to any student not yet admitted to the University.
 - 4. When the available number of waivers is used, application will be placed on a waiting list in case additional waivers become available by action of the New Mexico Commission on Higher Education or by cancellation of waivers to previously selected students.
