Job Title: Bilingual Spanish/English Therapist/Counselor

Summary of Position:

Under general supervision by Clinical Director, therapists at RCCCNM provide professional therapy for survivors of sexual violence, including sexual assault, abuse, and incest and to others impacted by these issues. The bilingual Spanish/English therapist provides case coordination and advocacy for Spanish speaking survivors by interfacing with various systems including employers, legal/court system, family/friends, medical, school, etc. Case load will include Spanish speaking clients and English speaking clients.

Requirements:

Masters degree and licensure in Counseling (LPCC, LMHC), Art Therapy (LPAT), Social Work (LISW), or related discipline. Experience working with survivors of sexual assault and abuse. Must be able to speak, read, and write Spanish and English fluently. Maintain licensing and continuing education per RCCCNM needs and professional standards. Duties and Responsibilities:

THERAPY

- Provide individual, family and group therapy for survivors of sexual violence and others affected by sexual violence.
- Carry manageable client caseload; conduct assessments, treatment planning, case management, and group and/or individual therapy.
- Provide assessment and treatment planning for survivors of sexual violence and others affected by sexual violence.
- Respect and maintain a high standard of confidentiality for all clients and cases served by RCCCNM
- Provide crisis intervention to clients as needed and facilitate emergency services as required.
- Participate in weekly group consultation, supervision and clinical meetings with other RCCCNM therapists
- Inform RCCCNM of developments and trends in areas of mental health and trauma treatment that may have a bearing on RCCCNM's programs, clients, staff, or community.
- Provide case management, case coordination, referrals and advocacy.
- Provide court testimony when necessary, including expert witness testimony.
- Maintain professional documentation and record keeping for client files. Design and implement systems for documentation.
- Participate in the administration of clinical programs based on organization and contractual requirements.
- Engage in ongoing evaluation of services and treatment modalities.

- Coordinate needs of the Counseling Program with RCCCNM's strategic planning and budgeting activities and in preparation of budget for the Counseling Services program.
