ABOUT THE FOREST:

The Inyo National Forest is a large, complex forest, encompassing about two million acres in California and Nevada. It contains several natural features of national and international interest. There are seven wilderness areas and six research natural areas, as well as the Mono Basin National Forest Scenic Area and the Ancient Bristlecone Pine Forest. Diverse geologic features, combined with the elevational extremes and attendant wide range of climatic conditions, result in tremendous floristic diversity on the Forest, with vegetation communities ranging from desert scrub, sagebrush scrub, and Pinyon woodland, to Jeffrey pine, Lodgepole pine and alpine habitats.
