# **Purpose of Position:**

The adjudicator basic position is the entry level position in the Administrative Law Judge/Adjudicator career ladder. This is a training position. The first year will be spent in formal classroom training and on the job training, learning to follow the policy and regulations of the Social Security Administration. The position requires the individual to utilize educational knowledge and critical thinking skills to request and analyze medical evidence and functional information and to determine whether or not the SSA Disability applicant meets the regulatory requirements for Social Security Disability payments and benefits. The most successful applicants will be goal oriented, have the ability to work independently and efficiently while also learning from constructive feedback, have the ability to analyze medical evidence and functional information and to rationalize their analysis of the information in a written document. The position requires the applicant to work in a production environment while also completing claims in a timely and accurate manner.
