**MINIMUM QUALIFICATIONS:**

Master's Degree in Psychology, Counseling or Social Work or Bachelor's Degree in Social Work and New Mexico Licensure as LBSW, LMSW, LISW, LPCC, LMHC, LMFT or LPAT. Provisional LBSW, LMSW, LISW, Licensure. Temporary LPCC, LMHC, LMFT or Temporary LPAT will also meet minimum qualifications. Failure to obtain full licensure

or loss of licensure will disqualify the person from meeting the minimum requirements. For positions providing clinical supervision, a Master's Degree in Psychology, Counseling, or Social Work, two (2) years of experience and full licensure as an LISW, LPCC, or LMFT is required.

**Employment Requirements:**

This position is designated a safety sensitive. Employment requires successful completion of post offer pre-employment physical and is subject to criminal background check and is conditional pending results of criminal background check. Must possess and maintain a valid New Mexico Driver's License as some statewide travel is required Completion of the Health Insurance Portability and Accountability Act (HIPAA).
