1. Non-thesis option for SOE EDLD, SPED, C & I

Associate dean of education, Jim Abreu, presented information:

Ed. Leadership can do a field project, or thesis, or portfolio, or, under this proposal, they can do a non-thesis option and take a comprehensive exam and 1 or 2 extra classes to make up for thesis.

Dr.. Montague moved approval

Dr. Mishler seconded

The following issues were discussed:

Terminology – there is no exam for the field project or thesis option.

Perhaps this could be called a Competency based option, a testing option, or a Comprehensive Exam Option.

Procedure: Students take an 8 hour written exam, made up of questions from the chair, an inside member, and an outside member. This is followed by an oral exam.

Students can re-take the written exam once, the following semester. Do they have to sign up for another credit? Ind. Study with chair?

Is this the best way to educate future educators?

If you do a proper oral examination – they have to show a mastery of the field.

How is quality control maintained?

Could the grading process and who grades be put in writing?

Amended to comprehensive exam option.

Dr. Sabutis amended his motion to ask for a report in one year and to change terminology, in particular the grading.
