Computer Use in the Behavioral Sciences, Psychology 327-Personal Adjustment, Psychology 378-Ethical Issues in Psychology, Psychology 418-Comparative Cognition, Psychology 462-Experimental Design and Analysis and Psychology 473-The Psychology of Suicide. Dr. Williamson indicated that these courses are being deleted because they have not been offered for many years. (Attachment 1)

After discussion, Dr. Ken Bentson made a motion to delete these courses from the catalog and globally as well. Dr. Jill Baker seconded the motion. The motion passed unanimously.

8.2. Undergraduate Research Curriculum-Psychology 301, 302, and 322-Dr. Ian Williamson.
