- 3. Approval of Agenda: agenda was approved

- 5. Communication from the Administration: Dr. Rivera
  - Faculty Searches NMHU received over 300 applications. There are applicants for every position, although some positions have more applicants than others.
  - The deans' searches are underway. Dr. Taylor will be replaced as chair of college dean's search.
