More variety would be nice.

More American history classes.

I would like to see HIST 225 Spain & Portugal offered.

Perhaps Middle Eastern/Asian history.

Answers to the question "What other recommendations would you make to improve the History program?" More classes per semester.

Availability of upper-level classes is not the greatest.

It would help me if more history classes were offered over ITV.

HIST 301 should be 2 semesters. Not enough time for thorough research.

I would recommend that the Research Methods class be a year long. More time to develop and learn a proper research paper.

I think the Research Methods class should be 2 semesters instead of one.

### **Use of Results**

Dissatisfaction with the number of courses offered by the department is a criticism that we see year after year. However, our request for a fourth historian went essentially nowhere, and in the current budgetary environment, clearly it will not happen anytime soon.
