#### 8. New Business

- a. Attendance Policy for students attending field trips. Instructor should set policy. Most instructors require students to notify them of absences, or potential absences beforehand, and it is up to students to find out what they missed.
- b. Policy for students kept late from prior class and then late for next class. AAC should send out e-mail to department chairs to remind faculty of time issues.

- c. Staff support issue. Faculty unable to participate if taking minutes. We should continue this discussion with recommendation to Faculty Senate.
- d. Committee members not showing up. A formal enforcement policy would be a change to the faculty handbook and must be voted upon by entire faculty. We could develop our own policy about attendance, such as adding those not in attendance to the minutes. The person should be contacted about their attendance, and then the 3<sup>rd</sup> notice should go to the department chair or dean. This item should be added to the next meeting's agenda for a vote.
