The Office of Institutional Advancement consists of the Foundation and Alumni Relations.

The Foundation is responsible for raising funds for student scholarships and special projects for the university. The Foundation Board consists of 25 members and five emeriti members. The Foundation was originally begun with funds donated by John Wilson, President of the Tandy Corporation, for whom Wilson Gym is named, and other community members almost 30 years ago. In the last two years the Foundation has raised, through investments and gifts, more than \$2 million, raising our current assets to \$8 million.

More than \$200,000 is distributed for student scholarships each year including book scholarships. The Foundation owns the Rio Rancho Center and leases it to the university for classes and university interests. Last year the Foundation bought the vacant land in front of the Rio Rancho site for future expansion when necessary. The Foundation also matches grants and endowments for scholarships and special programs such as the Media Arts department, music scholarships, and science expeditions.

The Alumni Relations office is responsible for developing alumni chapters, overseeing alumni events, and communicating with alums. Each year the Alumni Relations Office coordinates the annual Alumni Banquet held the Friday evening before the Homecoming game. At the banquet distinguished alumni, emeriti professors, community members and others are honored for their contributions to Highlands. This year, alumni chapters are being formed in Santa Fe and Albuquerque, and of course, Las Vegas. Activities are scheduled for wine tours, attendance at Highlands athletic events, and special events for each community.

In recent years, faculty and staff have increased their contributions to the university scholarship funds through contributions to the Give Me 5 campaign. This has been especially gratifying as other contributors always look to see if the institution supports the types of projects listed above. Our strength at Highlands clearly begins with our faculty and staff.

If you prefer to receive your W-2 form electronically, log in to Self-Service Banner, click on the Employee Tab; then, click on Tax Forms; then, Electronic W-2 Consent. If you agree to the consent form, click the box under “My Choice” and click on the submit button.

Policies/Procedures/Laws

Overview of the Family and Medical Leave Act (FMLA)

The FMLA is intended to allow employees to balance their work and family life by taking reasonable unpaid leave for certain family and medical reasons. The FMLA allows eligible employees to take unpaid, job-protected leave for up to a total of 12 workweeks in any 12 months for certain family and medical reasons and up to 26 workweeks in a single 12-month period to care for a covered service member with a serious injury or illness.

Eligible employees of covered employers are entitled to FMLA leave for:

- The birth of a child and to care for the newborn child;
- The placement of a child for adoption or foster care and to care for the newly placed child within one year of placement;

- Care for a family member with a serious health condition;
- The employee's own serious health condition that makes the employee unable to perform the functions of his or her job; or certain military-related reasons.

The Fair Labor Standards Act Exempt vs. Non-Exempt Employees

The Fair Labor Standards Act (FLSA) requires that employers classify jobs as either exempt or nonexempt. Non-exempt employees are covered by FLSA rules and regulations, and exempt employees are not.

Non-Exempt

Non-exempt employees are employees who, because of the type of duties performed, the usual level of decision making authority, and the method of compensation, are subject to the FLSA provisions including the payment of overtime. Non-exempt employees are required to account for all hours during the work week..

Non-exempt employees must be compensated for all hours worked, over 40 per week, at time-and-one-half.

Compensatory time may be granted in lieu of overtime pay; however, there are rules regarding compensatory time (see Personnel Policy 600).

Exempt

The Fair Labor Standards Act contains dozens of exemptions under which specific employees are exempted from overtime requirements. The most common exemptions are the white-collar exemptions for administrative, executive, and professional employees, computer professionals, and outside sales employees.

Under the Fair Labor Standards Act, exempt employees are paid a regular salary and are not paid based on the number of hours worked. Exempt employees are expected to devote the number of hours necessary to meet the responsibilities of a position and compensation does not change based on actual hours worked. Exempt employees are given the flexibility to exercise judgment both in how and when the work is done. They are expected to meet operational needs and are evaluated on results achieved. Exempt employees are not eligible for compensatory time.

The Fair Labor Standards Act-Additional Information Amendment (2010)

Effective March 23, 2010, the Patient Protection and Affordable Care Act amended the FLSA to require employers to provide a nursing mother reasonable break time to express breast milk after the birth of her child. The amendment also requires that employers provide a place for an employee to express breast milk.

Working Together As A Team


