### 5. Communication from the Administration

- 1. Dr. Aguilar has visited all but two departments.
- 2. Several faculty searches are moving along. There is a need for greater clarity for charges and timelines for each search.
- 3. Budget discussions have begun. Ms. Eileen Bentley is giving Dr. Aguilar summaries.
- 4. Sabbatical requests are under review as are tenure and promotion requests.

- 5. By the end of the term, the website should have clear information on academic programs and faculty information.
- 6. There will be a nursing accreditation visit at the end of March.
- 7. UNM passed a120 credit hour bachelor's degree. NMHU should look at this issue again.
- 8. Lottery scholarship: A new stipulation is that students have to complete 15 credit hours a semester to maintain eligibility. There are questions about consortium students and remedial classes.
- 9. Strategic planning in academic areas: Dr. Aguilar will be looking at strategic enrollment management, academic capacity for different majors, degree plans, and ways of making degree information accessible in different ways. Dr. Aguilar will ask departments to assess the processes that enhance degree completion or get in the way of degree completion.
- 10. Dr. Fries is talking about having an open forum on the results of the legislative session soon.

- 1. There is an academic forms committee.
- 2. The number of admissions applications are down this year; however, students admitted is about the same.

### 10. New Business: Dual Credit Student Report

1. Ms. Evonne Roybal-Tafoya, Educational Outreach Services (EOS) Director and Mr. Marvin Perea, AP New Mexico / Dual Credit Director

- presented information on dual credit enrollment and reviewed information packets.
- 2. There has been a large increase in dual enrollment students due to new graduation requirements. In fall 2012, there were 48 dual enrollment students. In fall 2013, there were 117 dual enrollment students. In spring 2013, there were 42. In spring 2014, there are 101.
- 3. To take dual enrollment classes, high school juniors need a 3.0 GPA; high school seniors need a 2.0 GPA. The GPA is an institutional requirement. Dual enrollment students are not eligible for remedial classes unless it is concurrent with another class.
- 4. The university waives tuition, the high schools pay for books, and students pay for special fees.
- 5. EOS is doing a needs assessment with the high schools. It is expected that the number of dual enrollment students will go up again in the fall.
- 6. There was discussion of resources for faculty on how to best teach dual enrollment students; how to prepare high school students to be college students, the in loco parentis issue, and concerns that high school students are now the majority in some classes.
- 7. Mr. Marvin Perea said he could give presentations at the high schools to dual enrollment students on college expectations. He suggested that faculty put something together that he could then present.
- 8. EOS had an ad hoc dual credit committee with a mix of faculty, school administrators, and EOS staff. They plan on reconvening the committee.

### 11. New Business: Bookstore

- 1. Mr. Ricardo Jimenez, bookstore manager, presented information on the online adoption tool for faculty. He asked faculty to contact him if they have questions about the online adoption.
- 2. This information will be emailed to faculty by Monday.

#### 12. Old Business

Regular meeting times for Senate Committees' in Faculty Handbook – discussion item.

<u>Possible wording for the Handbook</u>: All Senate committees shall meet a minimum of once per month but may meet more often as needed or as indicated in the Faculty Handbook descriptions of the committee (still a minimum once a month.)
