Approval of Meeting Agenda for January 21, 2014

Regent Marchi moved to approve the January 21, 2014 agenda. Regent Long seconded. Voting in favor were: Chairman Sanchez, Regent Long, and Regent Marchi. Motion passed unanimously.

Chairman Sanchez thanked Secretary Garcia for taking the time to present the NMHED funding formula proposal to the NMHU Board.

2014 NMHED Funding Formula Presentation – Dr. Jose Garcia, Cabinet Secretary Secretary Garcia presented the NMHED Funding Formula proposal (Attachments A, B & C). A lengthy discussion followed Secretary Garcia's presentation.

President's Report

President Fries reported the following:

- The Hispano Roundtable Dinner is scheduled for January 22, 2014 in Santa Fe.
- Las Vegas Night at the Legislature is scheduled for January 24, 2014 at the La Fonda in Santa Fe.

- The City of Las Vegas does not yet have specific information regarding the effluent lines.
- Spring 2014 enrollment rates are up slightly; retention rates for first-time/full-time freshman are also up slightly.
- The Santa Fe Community College is breaking ground on the Higher Education Center.
 The expected date of completion is January 2015.
- During this legislative session Highlands will be lobbying for:
 - An increase in funding for the Nursing Program, other universities received a rather substantial increase for their nursing programs whereas Highlands did not receive an increase.
 - Increased funding for Athletics. The budget was cut by 21% in prior years.
 - Startup money for the oil & gas concentrations approved by the Board during the December 2012 meeting
 - Capital outlay and infrastructure upgrades for fire safety and the electrical grid
 - Motor pool fleet (buses)
 - Lighting for the baseball field
- President Fries reported that he is working with the National Registry for College & University Presidents. The organization, in existence for 20-25 years, identifies people qualified for your job search. The hire contract is signed with the registry not the individual, Typical employment contracts are for 1-2 years.
- An arbitration hearing regarding the (3) dean searches will be held February 12, 2014.
- The Athletic Director search will be launched soon.

Dr. Teresita Aguilar, Provost/VPAA reported on the following:

- People at the university have been very receptive and welcoming
- · She is working with key individuals on retention rates and graduation issues
- She met with all the deans and some faculty and will be doing site visits at the centers
- She plans to work with the Registrar's Office and the Office of Institutional Research to examine data to better aid with retention and other issues.
