New Mexico Highlands University Board of Regents Special Meeting May 6, 2014

The New Mexico Highlands University Board of Regents held a special meeting on May 6, 2014 in the President's Conference Room, Rodgers Administration Building on the New Mexico Highlands University main campus in Las Vegas, New Mexico. Chairman Sanchez called the meeting to order at 1:37 p.m.

Approval of the Minutes from April 23, 2014

Trolley Renovation Project Floor Plans – Action Item

Mr. Mark Baker and Mr. Tomas Sanchez of Baker A+e provided a PowerPoint presentation (Attachment A) which included an overview of the proposed Trolley Building floor plans.

Regents present indicated they were satisfied with the proposed renovation plans for the Trolley Building. They thanked the Baker firm for accommodating the Regent's requests to be involved in the Trolley renovation plans.

President's Report

President Fries reported the following:

- Mr. Joseph Dominguez, ASNMHU President, was inducted during the ASNMHU Gala held on April 30th. Mr. Hector Balderas, New Mexico State Auditor and NMHU alum, was the keynote speaker at the event.
- The Historical Preservation Society held its' yearly convention on the NMHU campus. Regent Jesus López was impressive and engaging as the convention's opening speaker.
- Dr. Edward Martinez, ARMAS Director and Natural Sciences faculty, was named the USDA-US Department of Agriculture E. Kiki de la Garza Fellow. He will be participating in the program this summer.
- Three Athletic Director candidates will be interviewed on campus this week. President Fries thanked Dr. Trujillo for chairing the AD Search Committee.
- Carlotta Lockmiller, NMHU Foundation Board member, was on campus last week. She met
 with him, Dr. Aguilar, and Dr. Trujillo regarding the Foundation Board getting more
 involved with the university to raise money to expand Native American recruitment and
 counseling and to raise cultural awareness.
- The Higher Learning Commission has scheduled a site visit on September 28-29, 2015.
- NMHU Commencement Ceremonies:
 - The Registrar's Office identified 822 eligible graduates
 - The NMHU-Rio Rancho Commencement is scheduled for May 8, 2014. Ms. Monica Armenta, former KOB-TV anchor and Executive Director of the Communications Department at Albuquerque Public Schools will be the keynote speaker. Approximately 200 degrees will be awarded during the NMHU-RR Commencement ceremony.
 - 64 students from NMHU-Farmington will receive degrees in a joint commencement ceremony with San Juan College. UNM has 41 students graduating from UNM-SJC.
 - The main campus commencement is scheduled for May 10th at 2pm. Dr. Sylvester Perez will be the keynote. He is the Superintendent of San Antonio Public Schools, NMHU alum, NMHU Distinguished Alum, and is an H-Club inductee.
- He, Dr. Aguilar, and Mr. Baca met with Mr. Vincent Garcia, NMHU-Raton Center Director and various NMHU-Raton Center key stakeholders to discuss options to increase student enrollment at the center. A financial snapshot was provided (Attachment A).

- The search process for new men's and women's head basketball coaches is underway.
- The Las Vegas Optic and Albuquerque Journal printed articles on the discontinuation of the NMHU Rodeo program.
- During this Board meeting a petition was received urging that the NMHU Childcare Center remain open. President Fries disseminated the petition to the Board (Attachment B). A discussion regarding the financial liability the daycare poses on the university was held.
- Legacy Day was held on April 26th in which Chairman Leveo Sanchez and his mother Victoria D. de Sanchez were recognized for their multiple contributions to this university, community, the country, and internationally. The film created by Mr. Tom McDonald and Ms. Arianna Andreatta, Media Arts Department student, was outstanding. The film highlighted what a phenomenal role model Mr. Sanchez is. The video should be seen by all students in small rural schools to show that someone who grows up in a rural community does not have limitations; they can be successful through the achievement of an education.
