# **General Faculty Meeting Approved Minutes**

**Approved January 28, 2015** 

October 22, 2014 4:00 p.m. Sininger Hall 100

**Call to Order:** 4:07 p.m. with quorum obtained (29 voting and 2 non-voting Faculty attendees)

- 1. Approval of Agenda: Agenda approved with several additions
- 2. Approval of Minutes: Minutes from September 24 were approved

## 3. Presentation from Learning Communities

- a. Casey Applegate-Aguilar from the Academic Affairs office reported that despite several variations of a Freshmen Experience course, retention or success of students are not improving. A committee has been formed to develop a new program.
- b. They want to increase the rigorousness of the content, integrate it with two other classes, and have it be a three credit class.
- c. Other discussions involved faculty buy-in, administration support and qualifications of staff teaching it.
- d. Send comments to Casey.

## 4. Student Academic Integrity Policy revisions

- a. Proposed revisions came from a survey which was sent out several weeks ago.
- b. One of the concerns was when to use the policy, so definitions of minor and major cases were included, and brief procedures outlined.
- c. Appeals would follow the procedures of the Academic Affairs Appeals procedures.
- d. Concerns regarding implementation and how to tell if someone has been flagged. The 10 day window to submit paperwork is too narrow, however, the 10 days is after a penalty is imposed, not when dishonesty occured. The Registrar says he can develop procedures to implement the policy.
- e. A version is already in the student handbook. The BOR needs to approve policy change.
- f. Motion made to approve the student academic integrity policy with proposed changes. Motion carried with 1 abstention.

## 5. Faculty Handbook revisions – Dean Section (possible vote)

- a. Proposed changes were sent out last month for input.
- b. There are still concerns about administration evaluations, which the senate is working on. These should specifically state that it goes to the VPAA and the Faculty Senate.
- c. Motion made to accept the proposed changes. Motion carried unanimously.

#### 6. Faculty Handbook revisions discussion

a. Senate Committees – meeting time and absences and participation.

- i. Add in that if the previous chair is unavailable, the chair of Faculty Senate will call the first meeting.
- b. Absence of the Chair section. The intent is that when a chair becomes vacant in the middle of the year, the selection process does not need to wait until the next cycle.

- c. Where are we going? Need a living plan and blueprint. Support enrollment, graduate programs more or none.
