- h. A Special legislative session will be called in September with possible 1-5% budget cut. It will be retroactive for this year's budget.
- i. Campus life initiative Comedian Gabriel Iglesias coming in September. Outdoor office in Industrial Arts building. Free day at Indigo Theater.
- j. Faculty development week. Think about what we want. More advising time? Fewer meetings/sessions?

- k. Great Colleges survey shows a big disconnect between faculty and administrators perceptions of Highlands.
