 - i. An Ad Hoc committee was charged two years ago to revise the questions on the evaluation. There are two separate issues regarding the process of doing the evaluation, and how to get more participation by students. Discussions included the need for questions regarding how the student perceived his learning. Faculty were surveyed two years ago regarding the questions and these were selected.
 - ii. The senate will take into account today's comments and then vote on a final version to be implemented Spring semester.
