4. **Approval of Minutes from April 26, 2023 (attachment).** Motion made and seconded to approve the meeting minutes. Motion passed with 12 counted in favor; 0 in opposition; 4 to abstain.

5. Communication from the President (S. Minner).

- Updated on:
 - Moving forward with DNP efforts.
 - Reforestation; things happening by the day. Visit from group who looked at 3 sites on our property. Toured those 2 or 3 weeks ago. Things seem going good. We have the land, have the water. Easy egress to 4-lane highway. They visited sites. We have been advanced again. Final recommendation is imminent. This will be a major thing for the campus. Statewide, regional, national footprint to look at state of the art facility that could employ up to 150 people. Even if we are not selected, we WILL play (confident) in participating in the operations.
 - Campaign. (\$1 million naming, land, others).
 - Facilities improvements.
 - Athletics (e-sports, Vatos).
 - Sustainability.
 - Enrollment showing 2.4% increase fall to fall.
 - Campus Life.
- Talked about Transitioning. Going after more money where needed Nursing, Education, Social Work, and Forestry.

- Informed that sent out Strategic Plan template to unit chairs; due 09/25/23.
- Informed that the Legislative Finance Committee here this week. Has good handouts for HLC, HED, and Leg Finance Session. Got good information.
- Shared that we have roughly 440 new students b/c of new programs (Wiley programs, MA CRM).
- Said will be coming to Senate with a few things. Looking to Dual Credit program to increase that number. Compensation for universities for dual credit students is in the conversation. Will be posting for a Dual Credit Enrollment position.
- Said gave RR a draft of Academic Affairs Office FY 24 goals.
- Encouraged Department Chairs to meet October 30th deadline for department budgets.
- Said that Provost Council meeting is coming up; welcomed agenda items.
- Shared that Instructional Designers available to assist with course work. Given model for a "course shell." Asked for input about online platform, design. Senator brought up issues about how Brightspace looks, how it works in faculty purview.

7. Communication from the Chair (R. Rock).

• Appreciated everyone's involvement in Monday's Presidential Search Forum.

- Said there is a retreat coming up with Administration and Faculty, Student, Staff leadership.
- Reminded that there is a General Faculty meeting this afternoon at 4:00.
- Reminded that there is a Board of Regents meeting on Friday.
- Said there is an investigation on an email that was sent out in the spring.
- Shared that hasn't heard anything back from HLC or HED re General Faculty complaints.
- HLC report Dr. Minner shared we received accreditation approval. They will be back in 3 years with their visit (HR, payroll, accreditation issues). Still have issues re IPRA that the Faculty Senate is continuing to pursue.

10. Communication from the Staff Senate (R. Anaya). Brought up Spring 2023 request for additional holidays. Has had discussions with Faculty Senate, President Minner, and Board of Regents. KJ said generally in support of request, but reminded that the Staff Association is the sole bargaining unit for working conditions, under which this falls. N. Valenzuela commented on "low morale" has to do with issues outside of pay (lack of administrative support, poor staffing, pay issues). RA mentioned that looking for support. RR asked RA, CB what the status is with Staff Association. RB said in conversations. RA brought up issue of adoption of calendar, granting of administrative leave, and need for more time and notice.
