Program Mission:

Successful completion of this objective will be demonstrated by students receiving C or better on written assignments in Grades from the final courses grade in Cultural Anthropology 1140, Physical Anthropology and Archaeology 1215, Belief and Practices among Native Americans ANTH 4180; Radical Past and Present ANTH 4350; Gender and Anthropology ANTH 2350; Hispanic Southwest ANTH 4770; Methods and Theory in Archaeology ANTH 4100; Indigenous People of North America 2140; Archaeology of the Southwest 4130; Communication and Culture 4610; Indians of the Greater Southwest 4760 will be used for this assessment. Interpretation of Results for Outcome 3:

Regarding Outcome 3 Means 1, we met our goal with 74% of our students receiving a C or better on final course grades in the assessed anthropology courses. We believe that we achieved this high percentage of success because students were able to apply principles and methods of science to solve problems and draw logical inferences.

Utilization of Results:

In general, the program seems to be effective. One area that clearly needs work is improving the way in which we explain the advising process. We also plan to develop future exit surveys that will allow for longitudinal comparisons. Spring 2021 was a challenge for educators and students when shut-downs occurred during the onslaught of covid.

Changes to Program Based on Results:

The challenges of 2020-2021 reflect in the success of students and there has been an observable drop in grades compared to other years. The changes we will make to our program include a greater focus on online resources. The challenges of the past year have drawn out the need to develop better methods at connecting with students online, ensuring that our program meet the needs of a student body whose online presence is greater than ever. There should be a recommitment to pedagogical strategies that utilize an interactive relationship with our growing number of online students but also are linked with our live courses via such venues as Brightspace.

Retention Strategies:

Increase contacts with undergraduate students through advising, peer mentoring, revival of the Anthropology club, and extracurricular activities such as field trips and local/regional volunteer opportunities in anthropology.

Additional Comments

We plan to develop an exit survey that will provide for comparison over time, and will allow for analyses that are more comprehensive in the future.

The Outcomes Assessment process has encouraged us to look more closely at our overall program. We want to offer a program that prepares students to succeed at the later stages and is tailored our students' academic and post-graduation individual needs. One area we had identified, as a potential area for change is the need to require undergraduate students to take an advance (400 level) methods and theory course that addresses the four-subfields of anthropology. We will offer such a course to students who plan to attend graduate school. Those who do not plan for graduate studies will substitute the advanced method and theory course with a 400 level course that **aligns** with their plans. A future exit survey will provide specific information about our students' plans for their future and their respective academic needs.
